TERMS & CONDITIONS

All participants will follow the set daily plan.

No participants must leave the main group, or their walking group, without informing the coordinators or leaders first and must communicate with group leaders at all times.

All participants must have and show utmost courtesy, appreciation and respect for fellow participants, and the general public met during the trip. Control of language and self-discipline are, therefore, very important.

Participants must take note of any information given and abide by the instructions given. Time keeping will be very important.

Participants must look after their own personal belongings.

All the costs of accommodation, including room service and personal expenses (e.g. telephone calls), must be settled by the individual prior to departure.

The event is not a race; our basic philosophy is to help others succeed whilst having fun.

The coordinators' decision will be final as regards any interpretation of the rules and regulations.

Before or during the event, if participants have any concerns whatsoever about their personal fitness or health, they will communicate with the coordinators.

DISCLAIMER FOR LIABILITY AND/OR RESPONSIBILITY

The individual taking part in the Everest Kalapatthar / Island Peak Trek must complete this form.

1- Responsibility
